It's essential to recognize these symptoms promptly and initiate emergency medical care as soon as possible to improve the chances of survival. Immediate treatment of cardiac arrest involves cardiopulmonary resuscitation (CPR) and the use of an automated external defibrillator (AED). CPR helps maintain blood flow to the body's vital organs until medical help arrives, while an AED delivers an electric shock to restore the heart's normal

rhythm. In addition to CPR and defibrillation, Advanced Cardiac Life Support (ACLS) may be necessary to stabilize the patient and prevent further complications. ACLS involves administering medications to support blood pressure and heart function, as well as interventions to address the underlying cause of the cardiac arrest. After the initial resuscitation efforts, the patient may require further treatment, such as coronary angioplasty or bypass surgery, to restore blood flow to the heart muscle and prevent future cardiac events [1-4].

While some risk factors for cardiac arrest, such as age and family history, cannot be changed, there are several steps individuals can take to reduce their risk.
